

PIRATE MOMENT RELEASE FORM

I hereby authorize the Pattonville Athletic & Activities Foundation, a Missouri not for profit corporation, and anyone acting under its permission and authority (“**P2AF**”), the irrevocable and unrestricted right and permission to:

- a) Record my statement, voice and image (my “**Pirate Moment**”) on a video tape, audio tape, photograph, digital, electronic or any other medium.
- b) Use my name, likeness, voice and biographical material provided by me solely in connection with these recordings.
- c) Use, reproduce, exhibit or distribute in any medium (e.g., print publications, video tapes, CD-ROM and Internet) these recordings in whole or in part for any non-commercial purpose related to the mission of P2AF, including without limitation, tax-exempt fund raising activities. By way of example, P2AF reserves the right to organize, package and sell collections or albums of Pirate Moments to individuals and their families as a momento.

I waive any right that I may have to inspect or approve the finished product or products that may be used in connection therewith or the use to which it may be applied; provided such products do not include any intentional alterations or distortions of my name, likeness, biographical material.

I release, discharge, and agree to save harmless P2AF, its heirs, legal representatives, and assigns, and all persons acting under its permission or authority, or those for whom they are acting, from liability by virtue of any unintentional distortion, alteration, inaccuracy that may occur or be produced in the recorded presentation material or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel, slander, false light, or invasion of privacy. I understand that all such recordings, in whatever medium, including without limitation, all worldwide copyrights in and to such recordings, shall remain the sole property of P2AF.

I understand that P2AF intends to publish only those Pirate Moments with appropriate social behavior and has the right to review and discard, in its sole discretion, any and all Pirate Moments before usage. I also understand that, in connection with the publication, performance and display of Pirate Moments, P2AF will protect the integrity and high standards that Pattonville High School deserves.

The rights set forth in this release are granted on a royalty-free basis. I may notify P2AF in writing to request that my Pirate Moment be removed as soon as practical. However, I understand that copies of my presentation(s) or publicity materials that mention or include my Pirate Moment will not be recalled and that P2AF may not be able to remove cached copies of my Pirate Moment.
